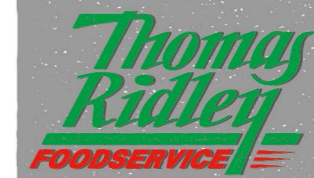

Process:

If requested as Halal. Halal material from Halal slaughterhouse. Product to be produced as first job in the day, through thoroughly cleaned machines. No Haram material to be in the same room during production. Raw material to be deboxed and unwrapped. Blocks to be fed through flaker, then as a continuous process through two mincers where it is minced and blended. Plate size 5 mm or as specified by customer. Mince is blast frozen, bagged, boxed, strapped and metal detected.

Metal Detection:

Free-flow 4mm ferrous,5mm non-ferrous and stainless.
