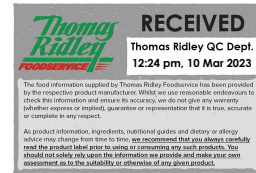

Reheat from frozen or defrosted to eat. Reheat in pack (no need to remove or pierce packaging) in a conventional oven, rapid cook (e.g. Merrychef, TurboChef) or microwave. For best results, use oven or rapid cook. Reheat in a conventional fan oven, pre-heated to 170C, for approx 35 mins. Reheat in a microwave (800W) for 2 mins 40 seconds and allow to stand for 1 minute before serving. Use a probe thermometer to ensure core is piping hot.

Storage Instructions:

Store frozen at -18C or below. Use before Best Before date. If defrosted, do not refreeze, keep refrigerated and change Use By date on back of the pack.
