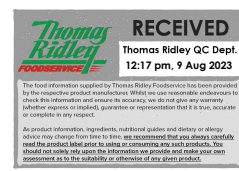

**Directions For Use :**  
**BOIL IN THE BAG**  
Fully immerse the pouch in boiling water; bring back to the boil and heat for approx. 1 hour, gently agitating the bag half way through.  
**STEAM**  
Place a pouch in a metal tray and make a tiny hole at the top, to release the pressure in the pouch. Steam for approximately 1hr. alternatively, empty the pouch contents into a suitable container large enough to accommodate the sauce and cover. The gastronorms provided should NOT be used to heat an entire pouch.  
**PAN HEAT**  
Empty pouch contents into a thick-based saucepan, heat thoroughly on a medium heat for approximately 45 minutes, stirring frequently to avoid burning, sticking or sauce spitting. Ensure that a minimum temperature of 82oC is reached throughout the product. Do not allow the sauce to boil, as this will impair the quality and may cause the sauce to spit  
**HEATING FROM DEFROST**  
Re-heating when defrosted:  
• Sauces must not be steamed or boiled in the bag. This is because the pouch material may have become brittle during freezing.  
• To heat on the hob follow the heating instructions contained within the customer guide.  
• Ensure that the contents are heated to a minimum of 82oC.  
• Do not re-heat products that have previously been heated.
