## **GENERAL DESCRIPTION**

Pitted prunes in juice are packed from properly selected and prepared dehydrated prunes. The fruit and fruit juice are filled and packed into 700g plastic containers, sealed and processed to achieve commercial sterility.

The jars are to be inspected, labelled, ink jetted and packed into cartons of 8. The trays are then shrink wrapped. A label containing the product barcode and BBE is to be applied to the long side of the tray.


