1. GENERAL DATA



Product description

Typical Thai curry sauce with pieces of bell pepper.

Ingredients

Coconut milk (water, coconut extract, maltodextrin, <u>milk</u> protein) (35%), water, pepper, rapeseed oil, shallot, tomato concentrate, natural extract (garlic, <u>milk</u>, coconut, onion, pea, coriander seed, cumin, ginger, chillies), sugar, modified corn starch, salt, turmeric, Thai basil (0.5%), garlic powder, black pepper, citric acid, thickener: xanthan gum.

Nature

Sterilized sauce in microwave-resistant doypack.

Allergens: milk.

Shelf life: 24 months from production date, at ambient temperature in the closed original packaging.

Preparation:

- Microwave: the pouch is microwave resistant. Heating time depends of the microwave (approx. 2 min. 750 W 1 kg = \pm 80 ° C).
- Combisteamer: heat the closed pouch with steam at max. 100° C for +/- 12 min.
- Pan: pour the right amount of sauce in a pan and warm up on low heat while stirring.
- Bain-marie: heat the closed pouch during +/- 15 minutes in hot water. The sauce can be kept warm in a bain-marie.
