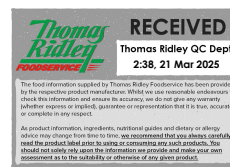

However, oats that are not contaminated with other cereals containing gluten (e.g., wheat, barley, and rye) and analysed to contain less than 20mg/kg (ppm) of gluten (as sold), may be labelled with the ingredient claim: ‘gluten-free’. The term ‘oats’ must however still be emphasised as the allergen.</p>

Microbiological	<p>Total viable count, Enterobacteriaceae. Result: Negative (Incubation 55°C, 7 days.)</p> <p>Aerobic spore formers, Anaerobic spore formers and Coliforms. Result: negative in 0.1 mL.</p>
GMO Status	<p>MOMA products are GMO free.</p>
